

[Seoul Food 2022] Entrance Guideline for Foreigners

1. Countries of visa waiver agreement and visa-free entry: K-ETA application should be completed at least 24 hours prior to boarding the flight

Countries of visa waiver agreement and visa-free entry (50 countries)

*K-ETA (Korea Electronic Travel Authorization) is an online visa application system for foreigners who wants to enter Korea for tourism, visiting relatives, participating in conferences or on commercial business. People from the countries of visa waiver agreement and visa-free entry must complete their application before entrance.

*In cases of invalid K-ETA, the issuance of Korea-bound airline ticket may be refused

2. Countries of temporarily suspended visa-free entry needs to obtain a visa

- Offline participants of AMS for the AKC pavilion should apply for visa to their embassies individually.
- AKC will forward official invitation letter by KOTRA once the participation list is confirmed.
